Are you an experienced and highly motivated researcher with expertise in mammalogy and/or ecology? Do you share our passion for communicating the latest research and evidence in mammalian biology and ecology? Mammal Review is currently looking for an Editor-in-Chief and Assistant Editor to lead the next phase of the Mammal Review, and to build the profile and reputation of this successful journal.

The Editor-in-Chief oversees the peer review of manuscripts, distributes the manuscripts to reviewing editors (based on their area of expertise), and is ultimately responsible for all editorial decisions made at the Journal. In addition, they commission high-quality review articles and topical special issues, manage the Mammal Review Editorial Board, and work closely with both the Mammal Society and the editorial office and production staff at the journal publisher.

The Assistant Editor will support the Editor-in-Chief in their role as well as having a specific remit to solicit and commission articles and special issues for the journal.

The journal recognises the importance of a board that is as diverse as it can be to better represent the breadth of the science and scientists and, in order to maintain this diversity, we welcome applications from leading researchers of any gender and from underrepresented and minority groups.

This post is a part-time contract (Editor-in-Chief honorarium £3,000 per annum, Assistant Editor honorarium £1,500 per annum) and located at the holder's host university or organisation, or home. Some additional financial support is available to facilitate attendance at meetings and relevant conferences to act as an ambassador for the Journal.
